_____(Initial) You may continue to redeem your membership facial/massage and other membership privileges as long as your membership is in effect and payments are current (cannot be used if membership is frozen or suspended).

_____(Initial) You may cancel 1 schedule appointment 24 hours prior to the scheduled time with no penalty or 2 or more appointments 48 hours prior to the scheduled appointments with no penalty. A no call or no show for scheduled appointments will be a \$50 charge to your credit card.

_____(Initial) These rates can not be combined with any other deals.
